We made [11 recommendations to the Metropolitan Police Service](#) in August 2020 to help tackle concerns around the use of stop and search in London.

s10 Co-operation to improve well-being

(1) Each local authority in England must make arrangements to promote co-operation between

(a) the authority;

(b) each of the authority's relevant partners; and

(c) such other persons or bodies as the authority consider appropriate, being persons or bodies of any nature who exercise functions or are engaged in activities in relation to children in the authority's area.

Amended by the Children and Social Work Act 2017 so that the police, clinical commissioning groups and the local authority are under a duty to make arrangements to work together, and with other partners locally, to safeguard and promote the welfare of all children in their area.

Applies to Local Policing Bodies, Chief Constables, NCA and BTP when exercising functions in relation to England.

S11(2) requires: Each person and body to whom this section applies must make arrangements for ensuring that–

(a) their functions are discharged having regard to the need to safeguard and promote the welfare of children; and

(b) any services provided by another person pursuant to arrangements made by the person or body in the discharge of their functions are provided having regard to that need
